

#### Narrative:

Down Home North Carolina is working to build power for poor and working people in NC's small towns and rural places. We have a strong focus on deep community engagement and 1:1 conversation.

Based on previous large-scale listening programs, we know that the communities we organize face major challenges meeting basic needs, and would benefit from policies like the Working Families Tax Cut.

With support from the Economic Security Project, Down Home NC set out to test messaging in order to understand the degree of support for the Working Families Tax Cut amongst our base, with particular attention to how support for the Cut mapped onto social challenges reported by respondents.

Between June 5 and June 19, Down Home NC is ran a paid canvas that knocked 3,164 doors and contacted 614 low-income residents in Jackson and Alamance counties. Using an iPad survey tool, we were able to log respondents contact information, demographic information, and their responses to survey questions.

### **Key findings:**

- 1. Overall, the support for the Tax Cut proposal was strong, with 80.6% of respondents in support.
- 2. Many respondents also reported challenges in meeting their basic needs. In general, people who reported a challenge were more likely to support the Tax Cut proposal, with the exception of people who reported "access to the internet" as a challenge.
- 3. While the majority of all people reporting challenges supported the Tax Cut proposal, people who reported the following challenges were most likely to be in support:
  - a. Problems related to prison (95%)
  - b. Keeping a roof over your head (95%)
  - c. Having a voice and a vote that matters (91%)



- 4. The Tax Cut proposal was popular with respondents in all racial categories. Overall, Black respondents had the most favorable opinion of the proposal, with 96% of Black respondents in support.
- 5. Likewise, the Tax Cut proposal was popular with respondents of all reported genders, with 90% support from male respondents and 88% support from female respondents.
- 6. Overall, all income categories supported the Tax Cut proposal, but support was strongest among people earning less than \$58,489 a year.
- 7. Among supporters of the tax cut, the most commonly reported challenges for respondents were:
  - a. The rising cost of living and housing (66%)
  - b. Not having a job that pays money (54%)
  - c. Addiction and substance abuse (51%)
